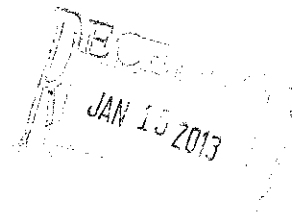

The parties hereto, intending to be legally bound, hereby mutually agree as follows:




